The report shall include a financial statement setting forth its assets, liabilities, income, and operating expenses as of the end of such fiscal year.

**Issue:** At the time of filing the report, the agency shall publish in a newspaper of general circulation in the community a notice to the effect that such report has been filed with the municipality and that the report is available for inspection during business hours in the Office of the Clerk or the Office of the Community Redevelopment Administrator.
