45 **1. A. Notice of Filing Annual Community Redevelopment Agency report for Fiscal year**

48 City Manager Gleason explained this item and how the city receives funds for this account.

50 Deputy City Manager/Finance Director Miller stated the following:

52 It is required by Florida Statutes 163.356(3) that a CRA Agency shall file a report with the  
53 governing body, on or before March 31 of each year a report of its activities for the preceding  
54 fiscal year. The report shall include a financial statement setting forth its assets, liabilities,  
55 income, and operating expenses as of the end of such fiscal year.



57 At the time of filing the report, the agency shall publish in a newspaper of general circulation in  
58 the community a notice to the effect that such report has been filed with the municipality and that  
59 the report is available for inspection during business hours in the Office of the Clerk or the  
60 Office of the Community Redevelopment Administrator.
