A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MASCOTTE, FLORIDA, PURSUANT TO SECTION 29 OF THE CITY CHARTER AMENDING THE BUDGET FOR THE 2016-2017 FISCAL YEAR BY INCREASING AND /OR DECREASING THE AMOUNT OF REVENUES AND EXPENDITURES WITHIN THE POLICE IMPACT FEE FUND, RECEIVED AND INCURRED AFTER THE ORIGINAL BUDGET WAS APPROVED; PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the original budget was approved on September 28, 2016, and

WHEREAS, additional building has increased the funds received for Police Impact Fees, and

WHEREAS, the City has decided to update the City's Impact Fee Schedule, allocating 1/5 of the cost (\$8,000) of the study to this Fund, and

WHEREAS, this amendment funds additional equipment needs of \$2,000, and

WHEREAS, it is anticipated that \$3,000 will be added to Reserves within the Police Impact Fee Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MASCOTTE, FLORIDA, AS FOLLOWS:

1. The City of Mascotte's Police Impact Fee Fund Budget for the fiscal year 2016-2017 is amended as follows:
